On Friday, August 29th, JCI successfully placed an oped in the **Sacramento Bee**, **Fresno Bee**, **SLO Tribune**, **Modesto Bee**, and **Merced Sun-Star**. The piece highlighted AB 1363 (Wyland's Law), Christy's story, and the urgent need to fix gaps in the protective order system. Thanks in part to this media push and advocacy, AB 1363 cleared its toughest hurdle with a 7-0 vote, even under heavy budget scrutiny.


